This template is written for the use of Parish Councils. It gives examples of the kind of information the Information Commissioner's Office (ICO) would expect the Council to provide in order to meet its commitment under the model publication scheme, introduced through the Freedom of Information Act 2000 (FOIA). In 2008, the ICO introduced a generic model publication scheme, for adoption by all public authorities that are subject to FOIA.

The model publication scheme commits the Council to 'produce and publish the method by which the specific information will be available so that it can be easily identified and accessed by members of the public'.

This template guide covers only information currently held by Stillingfleet Parish Council. If we do not hold some of the information listed below, it will be marked as 'not held' in the table.

The ICO expects the Council to make the information in this template available unless:

- it does not hold the information;
- the information is exempt under one of the FOIA exemptions or Environmental Information Regulations 2004 (EIR) exceptions, or its release is prohibited by another statute (eg UK GDPR);
- the information is readily and publicly available from an external website; such information may have been provided by another public authority or on its behalf in which case a direct link to that information is provided;
- the information is archived, out of date or otherwise inaccessible; or,
- it would be impractical or resource-intensive to prepare the material for routine release.
